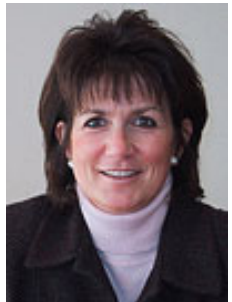

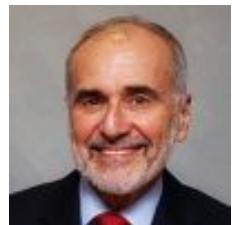

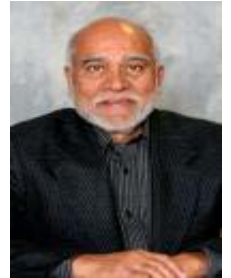


DRI FOUNDATION FELLOWS
