DISCUSSION	President Acharya presented his FY20 objectives: 1. External Review, 2. Strategic Plan, 3. Hire Division Directors, 4. Fundraising, and 5. Balance the Budget. Dr. Acharya also gave an update on the grants and contracts proposals and awards, and discussed two new projects: fire science study utilizing drones and a water resources study with the Nature Conservancy at 7J Ranch. The new organization chart was presented. Dr. Bob Gagosian has stepped down from the DRIF Board to serve as a Senior Advisor to the President, focusing on major gifts. Dr. Acharya also outlined the FY 22-23 budget priorities which were presented the Chancellor and his team yesterday, and were positively received.

DISCUSSION	Liepmann expressed appreciation for Trustee Aguirre's work with VP of Finance and Business Sheldon Flom on the annual audit. Auditor Sarah Crumby provided an overview of the audit process and results. Balance sheet and income statement appear healthy, and only one material weakness related to accounts payable for DRC was reported. Liepmann explained that the balances shown in the financial statements prepared by the auditors contain accruals and subsidiaries, so Trustees should rely on management reports to understand the financial status of the Foundation. A discussion ensued about bringing the Foundation's accounting back in-house at DRI, the controls in place, and oversight to be provided by FSO.

DISCUSSION	The Board considered the reappointments of Trustees John Entsminger and Linda Brinkley to second terms ending 2024 and Holger Liepmann as Treasurer through 2020. Trustee Michael Lynch has resigned and Trustee Roger Wittenberg has termed out and is not seeking reappointment.

DISCUSSION	With the upcoming departure of Mr. Flom from DRI, it is necessary to authorize additional individuals within FSO to act as signers on the Foundation's checking account. A resolution was presented to authorize the DRI Controller and DRI Budget Manager to be added as signers.

DISCUSSION	Janet Cathcart reported efforts are underway in planning a well attended 2020 Nevada Medal event that will generate a strong cash flow. A contribution appeal was sent in the annual report mailing, and an annual appeal will be sent next week to approximately 500 people. In addition, a digital appeal will go to approximately 400 additional individuals. Giving Tuesday, a social media appeal, is also ramping up. Trustees are asked to share these posts to help widen the audience. These efforts mark the largest audience solicited for year-end giving in many years. The Advancement department is carefully tracking the results of these campaigns and will report back on the outcomes. The Trustees requested a quarterly report on efforts and funds raised by the Advancement department.

AGENDA ITEM	DESERT RESEARCH CORPORATION UPDATE, RESTRUCTURING PLAN AND ELECTION OF OFFICERS FOR DRC <i>*VOTE REQUIRED</i>	PRESENTER: GALLAGHER
DISCUSSION	After reviewing relevant issues with legal and other experts, the Foundation was advised it would be best if the board of the DRC were composed principally of disinterested directors rather than persons who are either investors in specific projects or connected directly with either DRI or DRIF. It was also determined as the sole shareholder of DRC, it is appropriate for DRIF to have one of its Trustees as a member of the DRC Board.	
CONCLUSION	Brinkley made a motion to elect Mike Benjamin and Ken Ladd to the DRC Board of Directors, and for Michael Fagen to remain as the active Trustee on the DRC Board. Resolution to Establish Signature Authority for DRI Foundation for Transfer of Restricted Funds

Additional Language Added to Article III. Section 1. Powers and Duties. Item J.

RESOLVED: To authorize any person holding the following position within the DRI Foundation or within DRI will have signature authority on the DRI Foundation checking account(s) and other accounts with financial institutions:

Chair, DRI Foundation
Co-Vice Chair, DRI Foundation
Treasurer, DRI Foundation
Secretary, DRI Foundation
President, DRI
Vice President of Finance and Business, DRI
Controller, DRI
Budget Manager, DRI

The DRI Vice President of Development/Director of Advancement is to approve all expenditures.

For unrestricted funds one signature by an authorized person is permitted for amounts under \$10,000 USD. Two authorized signatures are required for amounts \$10,001 to \$50,000 USD. Amounts greater than \$50,000 USD require two authorized signatures and the formal approval of the expenditure in meeting minutes or the signature of the DRI President. Foundation Board Members are to be notified by email of transactions of unrestricted funds over \$100,000.

Restricted funds for DRI activities may be transferred to DRI for expenditure in accordance with the terms of the gift with the signature of the DRI President, Vice President of Development/Director of Advancement, Vice President of Finance and Business, Controller, or Budget Manager.

Subject: Recommendation for a new CPA Firm

The agreement with Eide Bailly (CPA firm), to provide year-end audit and tax preparation services, has ended. Due to the year-end approaching quickly, the Financial Services Office (FSO) requested quotes/bids from six local CPA firms, please see list below:

Included in these quotes are additional minor costs for the Desert Research Corporation (DRC), which became active this fiscal year and has incurred revenues and expense. Since 100% of the DRC stock is owned by the Foundation, it will be necessary to consolidate the financial statements of the two organizations.

Based on the CPA firm's experience, past work relationship with the Foundation, and the fees quoted, **FSO recommends Cupit, Milligan, Ogden & Williams for providing the year-end audit and tax preparation services. We request your approval to accept their quote** (please note: their quoted fees are comparable to the audit/tax fees paid in the last two years).

* Grant Thornton's quoted fees, do not include the cost for the tax preparation services.



DRI Foundation Trustee Expectations

Ambassadorship

- Represent DRI's mission, research and education experience and expertise and strategic goals to the external community.
- Gain a good understanding of the research and education priorities of DRI to be an effective ambassador to your friends, colleagues and business associates. Do your best to learn stories about DRI - the people, their equipment, or their space (laboratory/ field work), and the impact and importance of their research. Stay informed about DRI science, institutional strategic goals, and the impact of DRI research on Nevada and beyond.
- Partner with other DRI Trustees, DRI Foundation Staff, and DRI Leadership working towards the achievement of the DRI's and DRI Foundation's goals.
- When attending events hosted by other community and business organizations, look for opportunities to advance knowledge of DRI.

Participation & Engagement

- Be a proactive participant as a Trustee of the DRI Foundation. Except in extraordinary circumstances, attend all formal meetings of the Foundation in person. Read information provided, think strategically, request additional information, come prepared, and ask questions.
- Whenever possible, assume leadership positions on the DRI Foundation.
- If any potential conflict of interest problem arises, make sure to abstain from such discussion and votes.
- Actively support and participate in DRI Foundation events (including Nevada Medal Events) and DRI programs (lectures, events, meetings).
- Consider serving as a host for DRI Foundation events.

Financial Obligations

- Each Trustee should prioritize their donation to DRI among their major gifts. Support the DRI Foundation with an annual unrestricted personal gift of \$5000 to the general operating fund. The Foundation will accept contributions by a Trustee's foundation or business entity in lieu of such minimum personal gift, provided that such Trustee makes an additional personal gift in his or her own name. [See below]. (The Foundation Chair is authorized to modify this \$5000 requirement in circumstances where a Trustee requests such modification for personal reasons.)
- It is essential that there be 100% personal giving by all members of the DRI Foundation Board since it is a criterion for DRI to be able to apply for many important foundation and corporate funds. If your contribution is in the form of a company or foundation gift, make sure you contribute at least \$100 from personal funds.
